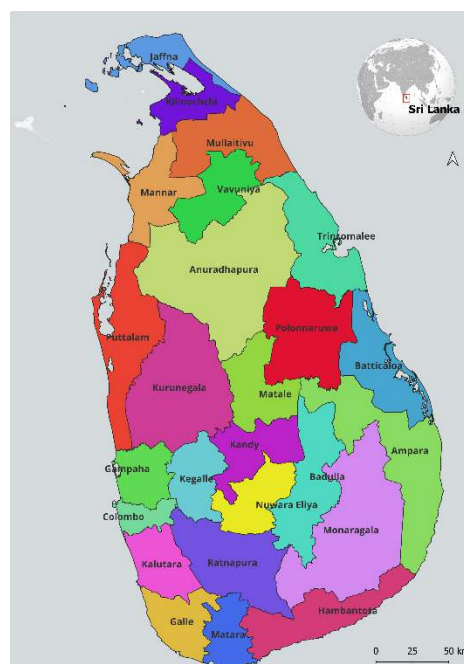
# 1. COUNTRY ANALYSIS

## 1.1 National Context

The Democratic Socialist Republic of Sri Lanka is an island nation located in the Indian Ocean southeast of India covering a land area of 65,610 square kilometers. and a coastline of over 1,790 kilometers.

Administratively the country is divided into nine provinces, 25 districts and further divided into 340 Divisional Secretariat (DS) divisions. Each DS division consists of Grama Niladari (GN) divisions (the lowest administrative level), totaling 14,008.

28.1% of the population is concentrated in the Western Province while the Colombo District, home of both commercial and administrative capitals, historically held the largest population, with urban sprawl, the Gampaha district has now overtaken with 2.43 million people versus 2.37 million in Colombo. Notably however, population density is still the highest in Colombo at 3,549 person per square kilometer.

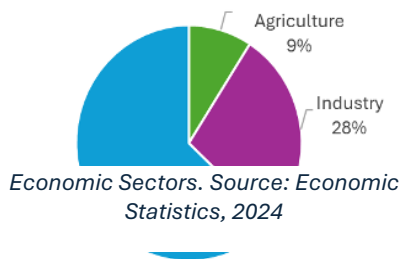

### 1.3 Economy

Sri Lanka has maintained stable macro-economic conditions emphasizing private sector-led development and foreign investment, leading to rapid growth in the Industrial and Service sectors (especially apparel and tourism), and a corresponding decline in the contribution of agriculture to GDP. Remittances from overseas workers also contributed significantly to the national economy.



The post-conflict era saw economic growth peak at 8% in 2010, By 2019 Sri Lanka graduated to Upper Middle Income status but, with back-to-back shocks starting with the Easter terror attacks in 2019, compounded by

the impact of COVID19, policy missteps and socio-political turmoil that aggravated an already fragile macroeconomy, Sri Lanka went into debt default in 2022. Since 2023, aided by an

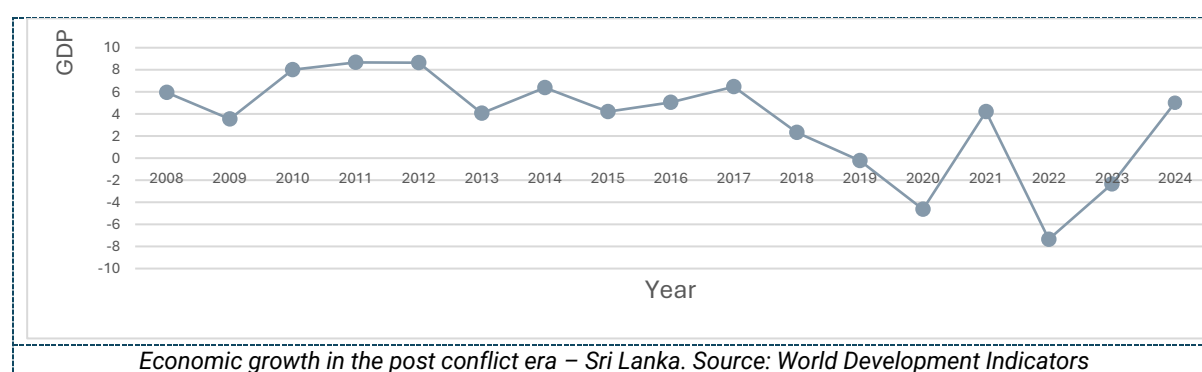
International Monetary Fund's Extended Fund Facility, debt restructuring, and prudent policies, the economy has shown slow recovery although poverty remains at 24.5% (World Bank Development Update, April 2025). With the landfall of Cyclone Ditwah in November 2025, the tentative gains made have been eroded and the necessity to Build Back Better and Safer is emphasized.

## 1.4 Poverty

With the economic downturn, the growth of a new urban poor within informal settlements is witnessed. This 'new poor' population contributed to tripling poverty post COVID and the economic crisis and are highly susceptible to the impacts of climate change – urban heat islands, flooding, vector borne diseases – and face constraints in accessing basic services, affordable accommodation, and safe and sanitary public spaces. Informal employment accounts for about two-thirds of employment in Sri Lanka, with around 5.5 million workers lacking access to formal safety nets (Sri Lanka: Selected Issues in: IMF Staff Country Reports, 2022), underscoring the urgency for inclusive urban policies.



The Multidimensional Poverty Index (MPI) indicates that 2.9% of the population in Sri Lanka is multidimensionally poor while an additional 14.3% is classified as vulnerable to multidimensional poverty. It disproportionately affects the estate sector (Global Multidimensional Poverty Index (2024)).

## 1.5 Gender and Social Inclusion

The Constitution of Sri Lanka secures women's rights, equality and prohibits discrimination based on sex. Yet women face persistent barriers to resources and opportunities despite high levels of literacy, education and healthcare attainments. Systemic gender inequality remains entrenched in key sectors such as economic participation<sup>1</sup>, political representation and access to assets, including land tenure, and livelihood opportunities.

Women continue to face a combination of systemic obstacles, such as gender-based violence and harassment at work and in public transport and entrenched social and cultural norms. They are also penalized by their disproportionate unpaid care burdens and higher gender pay gap. These lead to occupational segregation, limited skills and opportunities, undervaluing of work, and lower quality jobs.

With an aging population and shrinking labour force, if the full potential of women in the workforce is not garnered, Sri Lanka risks facing a prolonged period of economic stagnation, hence gender equality is a critical economic imperative for sustaining future growth and prosperity.

## 1.6 Historical and cultural heritage

Sri Lanka's written history spans over 2,500 years, with evidence suggesting human habitation between 75,000 to 125,000 years ago. This rich history has left behind a wealth of tangible cultural assets including religious and historical monuments and irrigation systems scattered throughout the island, some declared as World Heritage Sites by UNESCO. Similarly, the influence of diverse cultures and international trade has resulted in a rich and varied heritage of intangible assets such as pageants, temple festivals, diverse dance forms practiced by different communities, handicrafts and cuisines.

## 1.7 Biodiversity

Sri Lanka is globally recognized as part of the “Western Ghats–Sri Lanka Biodiversity Hotspot,” one of the 36 biodiversity hotspots identified by Conservation International, due to its exceptional biodiversity and high vulnerability. It also possesses exceptional endemism, with approximately 3,016 endemic species recorded of which 133 are on the IUCN Red List, including the Asian elephant.

Sri Lanka is divided into three main ecological zones, each possessing unique topography, climatic, geological, and biodiversity features (National Biodiversity Strategic Action Plan 2016-2022). While almost three quarters of the total land area had forest coverage in 1900, natural forest is 29.7% of the total land area in 2015 (UN-DESA, Sri Lanka Monitoring Frameworks Report 2023).

Depletion of forest cover is a result of historical and contemporary pressures including expansion of the plantation economy, land settlement, irrigation and mega-infrastructure development projects.

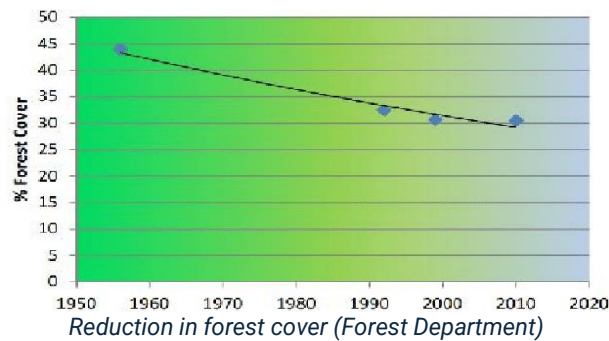

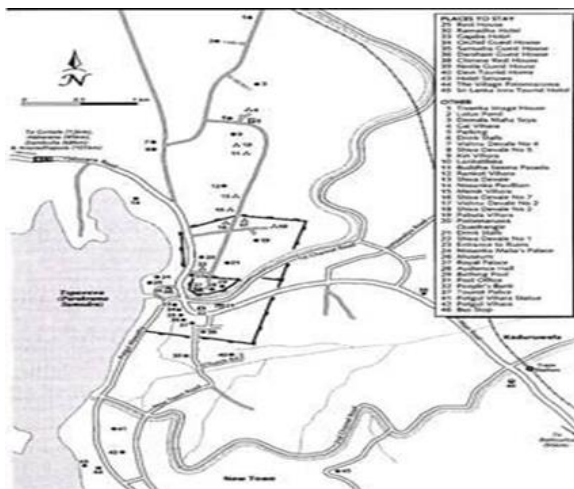

While Sri Lanka is a signatory to key international treaties on biodiversity and has a comprehensive policy regulatory framework which includes protected areas, the efficiency of conservation efforts is hampered by overlapping or unclear responsibilities among government bodies, inadequate funding and management capacity, together with a lack of community awareness and engagement in conservation efforts.

## 2. URBAN CONTEXT AND CHALLENGES

The urbanization process in Sri Lanka dates back to the 7th to 8th Century B.C with the development of several cities, known as “Nagara,” strategically located along international and internal trade routes, and irrigation tank systems. These early urban settlements exhibited hallmarks of complex societies, including social hierarchies, established governance systems, and craft specializations.

### 2.1 Post-Independence Urban Dynamics

Early post-independence era saw rapid population growth around Colombo, the commercial capital as well as other provincial capitals. This growth often led to the proliferation of urban low-income settlements known as “Watta” (garden) on marginal lands within the city limits.

The Urban Development Authority (UDA) was established by Act No. 41 of 1978 to promote integrated planning and implementation of economic, social, and physical development in urban areas, offering regulatory oversight and technical expertise to local authorities. The National Physical Planning Department (NPPD) was later established in 2000 through an

amendment to the Town and Country Planning Ordinance, responsible for formulating national physical plans.

## 2.2 Contemporary Urbanization Challenges and Characteristics

Present-day urbanization in Sri Lanka exhibits unique characteristics compared to its regional neighbors. Officially, it remains one of the least urbanized nations in the region, with just 19% of the population residing within officially defined urban administrative boundaries. However, this captures only those settlements termed as municipal or urban, but many Pradeshiya Sabha areas are urban by nature but listed as rural – hence the definition of urban does not consistently represent increasingly urban characteristics. Research suggests that urbanization is closer to 40% or higher.

Much of Sri Lanka's urbanization is characterized by urban sprawl, ribbon development along arterial roads, and rapid expansion in peripheral areas. This pattern has generated several developmental issues, including significant loss of productivity due to traffic congestion, increased costs for providing infrastructure and services, greater vulnerability to natural and environmental impacts.

Unlike many other South Asian countries, the percentage of shanties remains low in Sri Lanka, with most housing units seeing in-situ improvements, and access to basic services including individual pipe-borne water and metered electricity is notably high, while settlements are typically small. Furthermore, these multiethnic low-income communities possess long-standing and robust social structures and networks.

## 3. HOUSING, LAND AND BASIC SERVICES

Sri Lanka's housing landscape is diverse and complex. Although homeless is very low at 2,281 persons as per the Census of Population and Housing 2024, housing poverty is around 900,000 units irrespective of income levels and geographical sectors (urban, rural and estate). The annual demand for housing is estimated at between 50,000-100,000 new units per year, while the housing gap is estimated at 189,858 units, being 3.23% of the total housing stock and growing at a steady rate due to rising demand and inadequate supply. In addition, Cyclone Ditwah caused extensive damage to over 115,000 housing and critical infrastructure, underscoring the urgency of climate resilient development.

Although the demand for housing in cities is growing, issues of affordability, particularly of land, have limited supply especially in the low and middle-income segment. While the number of informal settlements in cities has stabilized, the number of housing units within the settlements are growing steadily due to population growth and domestic migration. Land tenure security is a major constraint for self-investment for housing quality improvement as most residents do not possess adequate legal land tenure. Although the recent urban regeneration projects aimed at improving housing and releasing land by relocating over 20,000 households into multi-story apartments, these have faced considerable criticism over unaffordable maintenance costs, poor quality of

construction, vandalism and most significantly the breakdown of established social networks (Sevanatha-Colombo Settlements Survey 2023).

Lack of adequate housing also has historical legacies particularly among the plantation communities and conflict affected households in the central, northern and eastern provinces. Families engaged in the plantation sector continue to live in deteriorating “line rooms” with minimal amenities and no tenure security. While government and donor investments have been made, over 175,000 units still require reconstruction and formal land allocation.

Although major investments have been made by the government and development partners for housing reconstruction in the conflict affected areas including construction of over 33,000 units by UN-Habitat alone, 137,000 units remain to be reconstructed. Landlessness is further exacerbated by state-citizen land conflicts, including government acquisition of land previously owned by communities displaced by conflict, as well as the government's limited capacity to re-issue lost land tenure documentation.

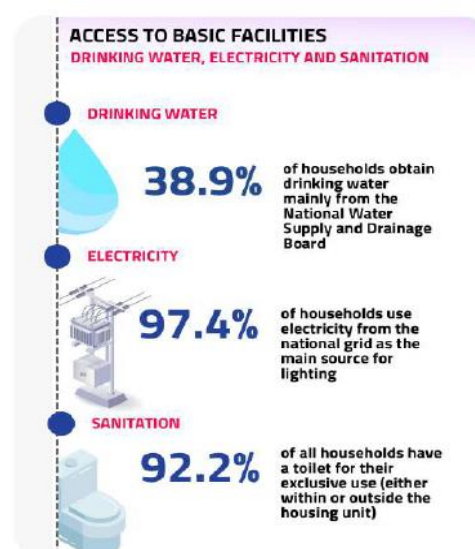
Meanwhile, the rental market remains weak, with rising demand for affordable housing unmet due to outdated legislation, high construction costs, and limited investment in middle-income housing. Renters face poor living conditions, long commutes, and limited options to expand access and supply across income groups.

A conservative banking sector lacking innovative housing finance products, restrictive policies including taxation on rental housing income, play a crucial role in limiting housing supply. Therefore, a multi-faceted approach to improve access to finance and housing solutions across the spectrum of various demand segments in the housing market through close collaboration between the public and private sector is required to provide equitable solutions to the housing crisis.

Current trends and developments have made the National Housing Policy (2019) outdated, while complex administrative processes continue to hinder sector progress. Revising the policy through wider stakeholder consultation to create a conducive and vibrant housing sector is strongly needed to streamline procedures, strengthen institutional capacities and create progressive investment to advance housing development in Sri Lanka.

### 3.1 Urban Basic Services

In general Sri Lanka's level of basic services remains at a satisfactory level in 2024. However, some aspects of basic service provision need urgent attention to ensure a satisfactory quality of life mainly for poor and vulnerable households. Although access to drinking water is high, access to piped water sources remains at 58%. The country records higher rate of non-revenue water in the piped water schemes accounting around 30% which makes water supply cost unsustainable. Over 55% of households use firewood as the primary mode of cooking contributing to both environmental and



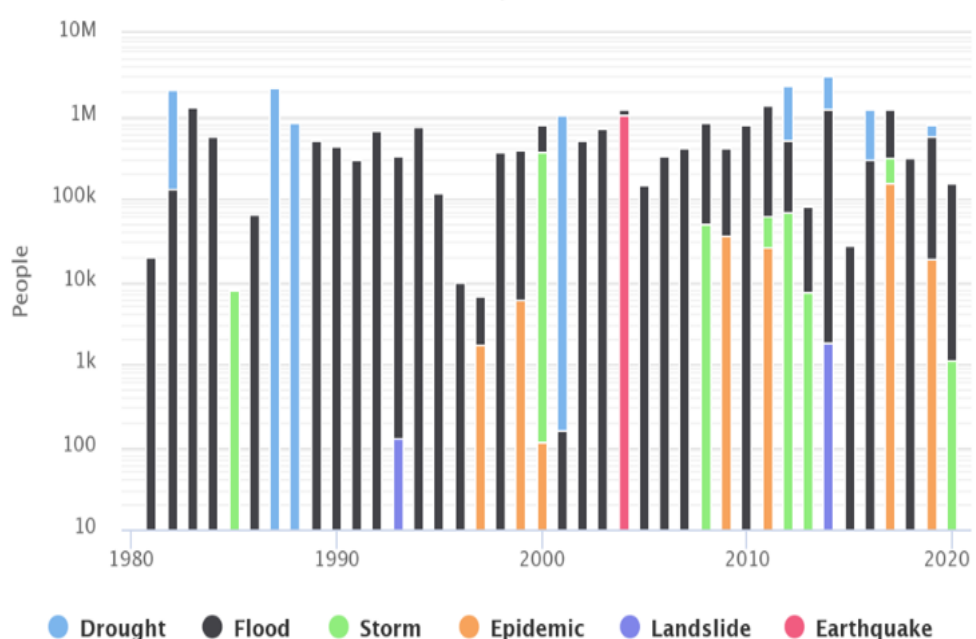

household air pollution. The conflict affected northern and eastern provinces and communities in the hill country districts of Nuwara-Eliya and Badulla, including estate sector communities, lag behind in basic service provision (Statistics 2024).

## 4. CLIMATE CHANGE

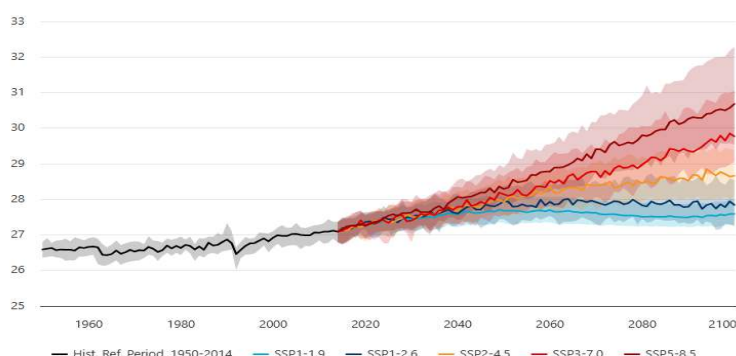
Sri Lanka faces a high and escalating climate risk, consistently ranking in the top 10 countries globally, and notably placed within the top five countries with the highest climate risk in 2016 and 2017. The nation's position in the Indian Ocean significantly influences its climate and associated risks. The country's climate is classified as tropical monsoon climate and characterized by three main climatic and three topographic zones.

A significant "Warm/Wet" trend has been observed over the past five decades with increases in temperature and precipitation. Historically, 96% of all natural disasters in Sri Lanka are climate induced. Between 1975 and 2022, the country experienced over 2,500 extreme weather events, costing approximately 0.4% of the GDP annually. Tropical storms are the most common, with cyclones occurring every 3-4 years. Heat stress is significantly impacting health, education and the economy due to reduced productivity.



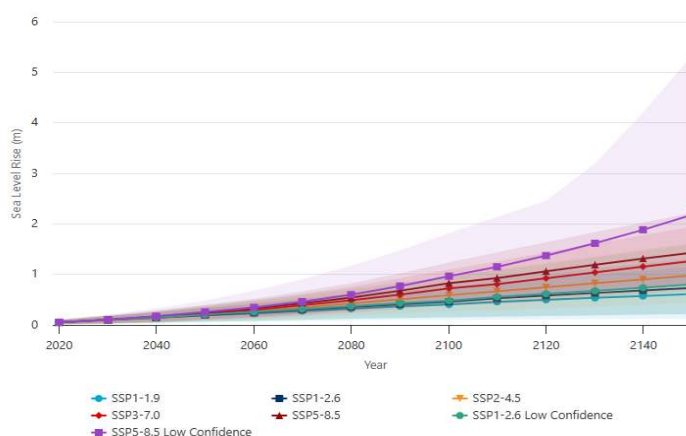

## 4.1 Future Climatic Projections and Impacts

Future projections (SSP1-2.6 to SSP3-7.0 scenarios) indicate a continuation of the warm wet trend. Sea levels are projected to rise by 0.2 to 0.23m by 2050, increasing to 0.46 to 0.72m by the end of the century, while fractional increase in tropical storms and cyclones is also predicted (climate

Change Knowledge Portal, World Bank). These changes are predicted to increase climate disaster losses to 1.2% of GDP under SSP1-2.6. Severe flooding under SSP3-7.0 could increase urban infrastructure damages up to US\$160 million annually, impacting housing, health, education infrastructure, and hydropower generation. Extreme rainfall is likely to intensify landslides, threatening 20% of Sri Lanka's land, particularly the Central Highlands. Critical infrastructure, including coastal arterial road and rail links, and main water supply systems, are vulnerable to sea level rise and salinity intrusion.

Health impacts, decreased yields of agriculture, fisheries and livestock products and lack of productivity in agriculture and in urban informal economy, are predicted due to extreme heat and water stress under high emission scenarios. The bottom 40% of the population, including those reliant on agriculture, will be disproportionately affected. The gender gap is expected to widen, and social cohesion is projected to decrease due to natural resource conflicts.

## 5. HUMANITARIAN CRISIS: Cyclone Ditwah in 2025

Sri Lanka suffered its worst disaster in two decades, as Cyclone Ditwah triggered massive floods and landslides in December 2025. The Post-Disaster Needs Assessment places recovery and reconstruction costs at USD 3.4 billion under the Build Back Better and Safer Framework. Housing and settlements - many completely washed away - emerge as one of the most politically and socially sensitive priorities, requiring USD 905 million. Restoring community road networks is vital to re-establish supply chains, market access, and essential services. Water infrastructure too is severely damaged, leaving rural communities without safe water supply. Environmental losses, driven by ecosystem degradation, weakened flood protection, and watershed damage, are estimated at USD 214 million, more than 60% higher than recorded damages.

Medium- long term investments focus on terrestrial and freshwater ecosystem restoration, coastal and marine habitat rehabilitation, wildlife recovery, and strengthened environmental valuation and biodiversity impact assessment systems, positioning nature as critical infrastructure for long-term resilience.

This project is supporting and strengthening socioeconomic recovery and resilience of estate and rural communities affected by the COVID-19 pandemic in Central and Uva Provinces of Sri Lanka. Key project outcomes: People have uninterrupted access to safely managed water supply, sewerage and waste management systems; and farmers and communities have improved agricultural productivity and food security.

### **Indian Housing Project in Plantation Areas**

Phase III of the Indian Housing Project in the Central and Uva Provinces of Sri Lanka constructed 1,615 houses, as part of India's overall commitment of 50,000 houses enabling the sustainable resettlement of plantation worker families in newly created cluster villages and small townships, under the MoU between the GoI and GoSL. A total of 17,662 individuals benefited from training

activities. Key lessons highlight the importance of early stakeholder engagement, timely land and beneficiary finalization, readiness of basic infrastructure, adopting an integrated and demand-driven approach, and allowing house design customization to enhance beneficiary ownership and satisfaction.

### **Support Initiative for Green Building Based Prevention and Control Measures for Vulnerable Communities in Mullaitivu District**

The project reduced risks from poor housing structures and promoted safer, cleaner, and climate-resilient cities in Asia and the Pacific during the COVID-19 pandemic through green building initiatives. In Sri Lanka, Cambodia, and Nepal, the project implemented community-based rapid assessments to identify urgent green building improvements and promote efficient use of energy, water, and other resources. In Sri Lanka, 110 staff and approximately 1,150 users of 15 community buildings benefited from energy-efficient cookstoves and solar lighting systems. A total of 171 households adopted alternative solar energy solutions and energy-efficient cooking stoves, improving indoor air quality, reducing costs, and enhancing resilience to climate change impacts.

### **Project: RE-Think Buildings Programme**

Led by UN-Habitat in partnership with UNEP and UNOPS, this project supported the One Planet Network Sustainable Buildings and Construction Programme for SDG 12. Its overarching aim was to promote a common approach to help countries leverage their buildings, construction, and housing sectors to achieve the SDGs. This initiative focused on mainstreaming resource efficiency in Sri Lanka's housing, buildings, and construction sector. Through stakeholder mapping, country assessments, and the development of a national "Roadmap for Buildings and Construction 2020–2050," it strengthened UN country teams' capacity to support governments in implementing sustainable, low-carbon, and climate-resilient building practices
